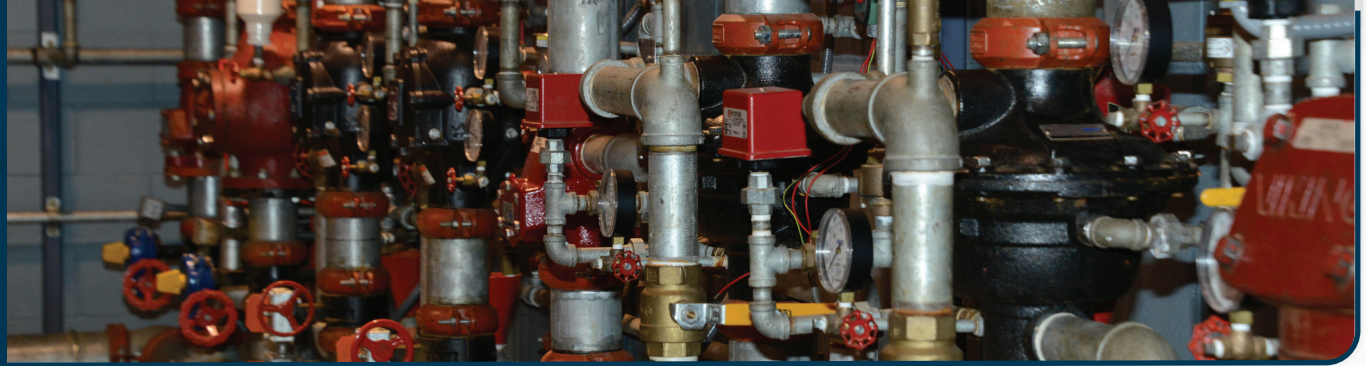
ASSE Certifications for a Stronger Workforce

Inspecting, testing and maintaining fire protection systems is meaningful work that comes with great responsibility — *your job performance can literally mean life or death.*

Use your knowledge and skills to inspect, test, and maintain water-based fire protection systems beyond the minimum requirements of NFPA 25. ASSE 15010 ITM Fire Protection Certification give employers and building owners added confidence in your abilities.

The ASSE 15010 certification program is the most stringent in the industry and requires a higher level of education and training.

Individuals certified to ASSE 15010 have the ability to knowledgeably and skillfully inspect, test and maintain water-based fire protection systems in accordance with fire protection industry standards and beyond the minimum requirements of NFPA 25.

Although there are other organizations that certify individuals as being competent in the inspection and testing aspects of NFPA 25, ASSE International developed the ASSE 15010 certification program to raise the bar for fire protection industry personnel and ensure public safety.

ASSE 15010 Certification covers both the evaluation of fire protection systems for conformance to codes and standards, and the evaluation of sprinkler system adequacy based on building uses, which is beyond the scope NFPA 25. A person certified to ASSE 15010 will have the qualifications to perform such evaluations, in consultation with a licensed engineer in some states.

Prerequisite:

- A minimum of five (5) years of documented practical experience in the fire sprinkler industry, including a minimum of three (3) years of inspection, testing and maintenance
- Completion of an 80-hour training course covering ASSE 15010 (Inspection, Testing and Maintenance of Water-Based Fire Protection Systems)

Certification Process:

- Pass a 200-question written exam
- Pass a practical exam covering course material and multiple system tests
- Recertification is required every three (3) years. Refer to program guidelines for recertification criteria details
